Since 1997, REDF has provided seed and growth capital and specialized advisory services to 219 social enterprises

Since 2016, REDF has partnered with the City and County of LA to implement LA:RISE, a collaboration between social enterprises, next-stage employers and Personal Service Providers (PSPs) to support transition to competitive employment for social enterprise employees. In 2020, REDF began providing capacity building support to social enterprises to leverage SNAP E&T funding in LA through the County of LA and nationally through USDA. In 2020, REDF partnered with the County of LA to provide \$46.8 million in COVID-19 relief funding to LA County based businesses.
